Mr. Taylor:

I am submitting this report pursuant to Paragraph 2(b) of EPA's November 16, 2022, Consent Decree. Attached is a map indicating the locations of the three on-site monitors and a summary table of recent 7-day rolling average values. Also attached are the compiled 30-minute average values for both H<sub>2</sub>S readings and meteorological data for each onsite monitoring station.

Paragraph 2(b)

The rolling 7-day averages for H<sub>2</sub>S readings for this period are summarized as follows:

As required by the Order, New-Indy is continually evaluating its ongoing operations and shall continue developing response actions which include the following, among others:

1. New-Indy's environmental consultant continues to remotely monitor and evaluates each monitoring station's performance on a regular basis, daily checking and validating the precision checks for each station.
2. The mill continues to supplement the WWTP with peroxide and ferric chloride as discussed in previous reports.
3. New-Indy continues monitoring and optimizing mill processes to minimize organic and chemical losses to the sewer. The sustained reduction in daily H<sub>2</sub>S levels and rolling averages continues to demonstrate New Indy's successful implementation of corrective actions.
4. The permanent activated carbon filtration unit continues to operate at the outfall structure (PAB, Post Aeration Basin) to potentially reduce variable ambient H<sub>2</sub>S and VOC emissions.
5. SCDHEC has approved Trial requests from New Indy Catawba for the use of an industrial odor-reducing aerosol spray (not a masking agent, but an odor reducing agent) and oxygen injection into the primary clarifier influent.

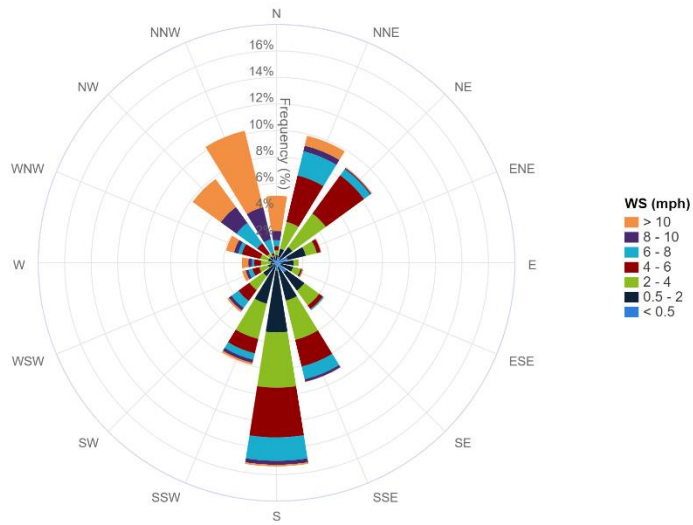
